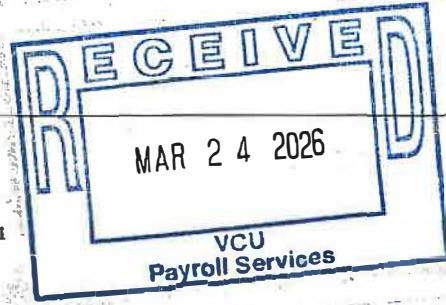

- You purchase items subject to Vermont Sales Tax that are used in the operation of your business, however the seller does not charge sales tax.

You must report and pay sales and Vermont use tax on these items in the month following the collection of tax. Occasional filers are required to file and remit tax due through myVTax, the Department's online filing site.
